ADHOC FEE ORDER

The Committee received various proposals of fee fixation from the institution which are establish in the year 2016-17 for fixation of Adhoc Fee as Deposit. Since this is the first year of the institutes, the details of actual expenses for the last one year of the institutes are not available for consideration of the Committee. Therefore, looking to the fee structure available to established course of like said institutes , the Committee approves the fees as a Deposit for the year 2016-17 on normative basis to all such institutions as per Annexure-A(VI).

The separate Fee Structures are determined for 75% of government seats as well as 25% of management seats except Post graduate Medical Course.

It is made clear that if any management seat remain vacant or the institution surrenders the management seats to the Government for admission , in that cases fee would be at par with the government seats.

For Gujarat Adani Institute of Medical Sciences, Bhuj : The Committee recommends the college to devise a fee structure proving for differential fee for the degree/diploma courses, provided the average fee from all the courses and from all the students as fees indicated in Annexure – VI.

In view of cost of securing bank guarantee, the College should, as far as possible, refrain from insisting on bank guarantee. The Committee advises that the College should work out an alternate form of security/guarantee to ensure that no student once admitted, abandons the course half way resulting into loss of opportunity for others. In this background, the college is free to work out an arrangement to ensure that the student leaving the course before completion pays the full amount of the Course for the entire term of two or three years as the case may be.

The Final fee structure will be approved after getting a fresh proposal from institutions with details of Audited Accounts for the year 2016-17 . Fee specified above is to be adjusted by the students/institute as per the final fee structure decided by the Committee.


The College / institute is also advised to comply with following additional conditions:

- a. The College shall not take fees for the full course at the time of admission. The fees should be collected per semester / term of 6 (Six) months as the case may be.
- b. The College shall not ask for any bank guarantee or security of any kind from students or their parents.
- c. The College shall not force on the students, any facility including hostel and transport as part of the condition for admission or its continuity till the end of the full tenure of the course.
- d. The College shall notify the fee structure on the College Notice Board and display copy of this order on its Mandatory Disclosure Link on its web site.
- e. The College is advised to work out a financial aid scheme through which it shall provide waiver or relief or concession in fees to the students belonging to weaker section of the society.
