Therefore, looking to the fee structure available to established course of like said institutes, the Committee approves the fees as a Deposit for the year 2017-18 on normative basis to all such institutions as per Annexure-A(XI).

**The separate Fee Structures are determined for 75% of government seats as well as 25% of management seats except medical college for which only government seats adhoc fees as deposit decided.**

**It is made clear that if any management seat remain vacant or the institution surrenders the management seats to the Government for admission, in that cases fee would be at par with the government seats.**
