**Order of Fee fixation for the Management Quotaseats of Medical, Dental and
Para-Medical Colleges**

1. The Fee Regulatory Committee (Medical) (hereinafter referred to as “the Committee”) has been constituted under section-9 of **the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007, Act 3 of 2008**(hereinafter referred to as “the Act”) enacted by the State Government to make special provision, inter-alia, for fixation of fees in professional medical education colleges or institutions and for matters connected therewith or incidental thereto.

2. Section-2(h) of the Act defines “Management Seats”. It means twenty-five per cent seats of the professional courses of the total approved seats in the unaided colleges or institutions including fifteen per cent Non-Resident Indian seats.

Section-2(i) defines “Non-Residential Indian seats” means fifteen percent, seats reserved for children or wards or the dependents for the education purpose, of the Non-Residential Indian, to whom admission is to be given in the professional educational colleges or institutions;

3. The Government of Gujarat by its Ordinance dated 10th June, 2016 (Gujarat Ordinance No.2 of 2016) brought amendment to section-2 and section-6 of the Act.

The Ordinance read as under:-

“3. Amendment of section-2 of Gujarat 3 of 2008 – In the principal Act, in section-2,-

(i) In clause (h), the word “including fifteen year per cent. Non-Resident Indian Seats” shall be deleted;

(ii) Clause (i) shall be deleted.

4. Amendment of Section-6 of Gujarat of 3 of 2008:- In the principal Act, in section-6, in clause (ii) second proviso thereto shall be deleted.

In view of this the 15% of Non-Resident Indian seats stood deleted.

4. In view of the amendment the Health and Family Welfare Department, Government of Gujarat addressed letter dated 23.6.2016 to the Member Secretary of the Committee stating that since the NRI Quota of fifteen percent stood deleted from 25% of the Management Quota, the Self Financed Medical as well as Dental Colleges tend to suffer great financial loss. Therefore, the representatives of the Self Financed Medical and Dental Colleges represented to the Government to re-fix the fee structure for the Management Quota from the academic year 2016-17. Considering the representation the Government by said letter requested the Committee to re-fix the fee for the Management Quota from the academic year 2016-17.

In pursuance of the said request of the Government, the Committee by its letter dated 28.6.2016 intimated the institutions that their fees from the academic years 2016-17 for the Management Quota was required to be re-fixed

they may submit their fee proposals within 10 days to the Committee. The proposals from the Medical Colleges were received by the Committee.

In the meanwhile the Dental Colleges and some students challenged the Ordinance by filing Special Civil Application No.9915 of 2016 and its cognate petitions in the Hon'ble High Court of Gujarat. The Hon'ble High Court of Gujarat by its CAV JUDGMENT dated 16.8.2016 partly allowed the writ petitions and set aside the aforesaid Ordinance to the extent it related to genuine NRI / NRI proper i.e. children or wards of the Non-Resident Indian. The Hon'ble High Court also made it clear that this would not apply either to the NRI dependent or NRI sponsored.

5. In view of the judgment of the Hon'ble High Court of Gujarat the Government of Gujarat passed Gujarat Act 13 of 2016 amending section 2(i) of the Principal Act and retaining the original provision of 15% NRI seats in respect of genuine NRI / NRI proper i.e. children or wards of the Non-Resident Indian only. The NRI dependent and NRI sponsored are taken out of the purview of the definition of NRI seats.

6. Thereafter the Dental Colleges which had not submitted their proposals because of the pendency of their petitions in the Hon'ble High Court of Gujarat submitted their proposals on 24th August, 2016.

7. The Committee took into consideration all the proposals of the Medical as well as Dental Colleges for re-fixation of the Management Quota fees. While re-fixing the fees for the Management Quota, the Committee kept in view the fact that few admissions of the NRI of the categories mentioned in the amended provision were taken in the past in Self Financed Institutions in Gujarat State and therefore it re-

fixed the fee for the year 2016-17 accordingly so as to avoid any financial loss being caused to the institutions.

8. The fees indicated in annexed sheet include all types and kind of fees such as Tuition Fees, Clinical, Library, Laboratory, Computer Centre, Gymkhana, Internet, Sports and Recreation and Self / Personality Centers etc except Hostel fee and Transportation fee. Therefore the college or institution is advised not to collect any other fee from the students except the fees as mentioned in Annexure attached here with. Any such unauthorized collection of fee may invite punitive action as per the law.

9. **The fee structure determined by this Committee shall be binding for the year 2016-17. The fees so determined shall be applicable to only new students admitted in that specific academic year and shall not be revised till the completion of their professional course in that college or institution i.e. the students admitted in the year 2016-17, the fees of 2016-17 are applicable to those students up to the completion of their course.**

It is made clear that if any management seats remain vacant or the institution surrenders the management seats to the Government for admission , in that cases fee would be at par with the government seats.

10. The College / institution is also advised to comply with following additional conditions:

- a. The College shall not take fees for the full course at the time of admission. The fees should be collected per semester / term of 6 (Six) months as the case may be.

- b. The College shall not ask for any bank guarantee or security of any kind from students or their parents.
- c. The College shall not force on the students, any facility including hostel and transport as part of the condition for admission or its continuity till the end of the full tenure of the course.
- d. The College shall notify the fee structure on the College Notice Board and display copy of this order on its Mandatory Disclosure Link on its web site.
- e. The College will be free to fix fees for NRI students up to 15 % of the intake capacity subject to intimation of the same to the Fee Committee. The difference of amount of the fees from the NRI category students and Management students shall be used by the institution for providing scholarship to the students and/or increasing infrastructure facilities. The college shall also furnish all the information pertaining to the utilization of excess fees from the NRI category students as per the Information Memorandum submitted by the institute to the Fee Regulatory Committee in the next block of three years.**
- f. The College is advised to work out a financial aid scheme through which it shall provide waiver or relief or concession in fees to the students belonging to weaker section of the society.

11. This order has been made under section 10 of the Act hence violation of any of the provisions contained in it will render the management of the institution liable to be proceeded against under section 14 of the Act
