INSTITUTE : Sahjanand College of Nursing, B/h. Kalptaru Park, Ahmedabad-Kalol Highway, At & Post Zundal, District-Gandhinagar.

Sahjanand College of Nursing, is a new institute which has come up in the academic Year 2008-09. Since this is the first year of this institute, the details of actual expenses for the last two years of the institute are not available for consideration of the Committee. Therefore, looking to the fee structure available to established Degree Nursing College, the Committee approves on normative basis as the fees as a Deposit for the year 2008-09.

Fees as deposit per annum for 2008-09 :- Rs. 45,000/-

The Final fee structure will be approved after getting a fresh proposal from institution with details of Audited Accounts for the year 2008-09 . Fee specified above is to be adjusted by the students/institute as per the final fee structure.

Other conditions to apply :

- The college will not take fees for the full course at the time of admission. The Fees should be collected per term.
- The college will not ask for any bank guarantee or security of any kind from students or their parents.
- The College will not take any other fee, deposit, charge or advance in the name of gymkhana, computer center, internet facility, laboratory, library, sports, recreation, self development etc.
- The College will be free to fix fees for NRI students up to 15% of the intake capacity subject to intimation of the same to the Fee Committee. All additional fees from NRI students in whatever form will be utilized for the benefit of students such as from economically weaker section of the society as per the directions given by the Supreme Court in its judgement in the case of P.A.Inamdar and Others V/s State of Maharashtra and others.
