**Order amending order for fixation of fee structure dated 17th July, 2007 for
Post Graduate courses of H.M.Patel Centre for Medical Care & Education
for the academic years 2006-07, 2007-08 and 2008-09**

1. H.M.Patel Centre for Medical Care & Education by their letter No. HMPC:PG:FEE:2008:001 dated 28/02/2008 made representation on various issues for reconsideration of fees fixed by the Committee in respect of Post-graduate Courses of the Institute run by Charutar Arogya Mandal. The same was followed by letter No.CAM:109/4/14 dated 17/04/2008 from Ms.Amrita Patel, Chairman of the Charutar Arogya Mandal summarizing the issues.
2. The Committee has duly considered the aforesaid issues and response of the Committee to each of the issues raised is as under :
 - (i) As regards the first issue, the Committee has studied the pattern of capital investment made by the college for Post-graduate courses and also the past history of investments made by the Mandal. In view of the same, instead of allowing 12% i.e. 5% for inflation and 7% for development as adopted in the original order dated 17th July, 2007, the Committee is of the opinion that in the Post-graduate courses, inflation at 5% and development allowance at 10% i.e. total 15% be considered. The effect thereof has been given in the recommendation of fees for 2006-07, 2007-08 and 2008-09 provided hereunder.
 - (ii) As regards the issue of not providing increase in cost considered for the year 2006-07 as compared to 2005-06, the Committee finds that while passing the order dated 17th July, 2007, the Committee has considered the audited figures of costs for the year 2005-06 only which were made available to the Committee. In view of the same, while considering fees

for 2006-07, 2007-08 and 2008-09, increase for inflation and development allowance ought to have been allowed on the cost worked out for 2005-06. Accordingly, in recommending fees for 2006-07, allowance for development and inflation at 15% be added to the cost worked out for 2006-07 and thereafter accordingly for 2007-08 and 2008-09.

- (iii) As regards the issue for providing inflation at a higher rate i.e. 13%, Committee has studied the same and the Committee is of the opinion that in view of the generally prevailing rate of approximately 5% which has been considered for other institutes also, Committee is unable to accept the proposition and inflation rate adopted at 5% is considered proper and reasonable by the Committee.
- (iv) As regards issue for flexibility in fee structure for individual subjects, it is pointed out that the Committee has recommended average fee rate. If the college desires to have different fee structure for individual subjects within the overall ceiling, details of cost in respect of each individual subject has to be submitted to the Committee and only then Committee will be able to consider the same.
- (v) As regards the issue regarding calculating fees on the basis of number of seats actually available, Committee is unable to accept the suggestion in view of the fact that it would lead to uncertainty and is not in accordance with the practice generally adopted by the Committee to fix up the fees on the basis of number of seats sanctioned.
- (vi) As regards issue of obtaining bank guarantee from Post-graduate students, Committee has considered the issue in wider perspective in line with the other institutions and is unable to agree to this suggestion. Moreover, according to the Committee, the number of students leaving the Course also, may not be substantial.

3. Considering the above, the fees recommended for 2006-07, 2007-08 and 2008-09 are amended as under :
