ADHOC FEE ORDER

The Fee Regulatory Committee (Medical) (here in after referred to as The Committee) has been constituted under section-9 of The Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007, Act No. 3 of 2008 (hereinafter referred to as 'The Act') enacted by the State Government to make special provision, inter-alia, for fixation of fees in professional medical educational colleges or institutions for admission of students.

The Fee Regulatory Committee received proposal of fee fixation from the institution which is establish in the year 2023-24(for fixation of Fee as Deposit). Since this is the first year, the details of actual expenses for the last one year of the institution are not available for consideration of the Committee. Therefore, keeping in view the fee structure of the established institution running the same course, the Committee has fixed the Adhoc fees as worked out by the C.A., Member as Deposit for the year 2023-24 on normative basis for all such institution as per Annexure-(II)

Separate Fee Structures are determined for 75% of government seats as well as 25% of management seats

It is made clear that if any management seat remains vacant or the institution surrenders the management seats to the Government for admission, in that case fee would be at par with the government seats.

The Final fee structure will be determined after getting a fresh proposal from institution with details of Audited Accounts for the year 2023-24. Fee specified above is to be adjusted by the students/institution the case may be, as per the final fee structure that may be determined by the Committee.

Each College/Institution is also advised to comply with following additional conditions:

- It shall not take fees for the full course at the time of admission. The fees should be collected per semester / term of 6 (Six) months as the case may be.
- It shall not ask for any bank guarantee or security of any kind from students or their parents.



- c. It shall not force on the students, any facility including hostel and transport as part of the condition for admission or its continuity till the end of the full tenure of the course.
- d. It shall notify the fee structure on the College Notice Board and display copy of this order on its Mandatory Disclosure Link on its web site.
- e. The College/ Institution will be free to fix fees for NRI students up to 15 % of the intake capacity subject to intimation of the same to the Committee. The difference of amount of the fees from the NRI category students and Management students shall be used by the college/institution for providing scholarship to the students and/or increasing infrastructure facilities. The college/institute shall also furnish all the information pertaining to the utilization of excess fees from the NRI category students as per the Information Memorandum submitted by it to the Fee Regulatory Committee in the next block of three years.
- f. The College is advised to work out a financial aid scheme through which it shall provide waiver or relief or concession in fees to the students belonging to weaker section of the society.
- g. This order has been made under section 10 of the Act hence violation of any of the provisions contained in it will render the management of the institution liable to be proceeded against under section 14 of the Act.
